# GUIDE

## 1. Membership Categories

- **Who Qualifies for Franchisee/Individual Membership?**

Membership of the Franchise Association of New Zealand under the category of Franchisee/Individual is open to an individual who wishes to benefit from the services and opportunities provided by membership, but who is not able to join through any organisation or company to which they belong. Individual members are not entitled to use the member logo or to vote during board elections.

- **Who Qualifies for Student Membership?**

Membership of the Franchise Association of New Zealand under the category of Student is open to any student at a recognised tertiary institution who wishes to benefit from the services and opportunities provided by membership in order to further their studies. Student members are not entitled to use the member logo or to vote during board elections.

- **Who Qualifies for Associate Membership?**

Membership of the Franchise Association of New Zealand under the category of Associate is open to either a franchise association or other form of organisation of similar type with similar aims and whether established provincially, regionally, nationally or internationally or on some other basis; or is, in the opinion of the Board an association or other form of organisation whose membership of the Association could benefit the Association.
